It is further agreed that a late charge of \$20 per quarter hour or fraction thereof will be charged for students not picked up promptly at 6 p.m. Teachers and staff will remain with students until parents arrive. In the event that parents or emergency contacts cannot be reached, proper authorities will be notified.

I understand that neither the Extended Day or Holiday Care Programs will operate on snow days, and the program will be cancelled when inclement weather requires early dismissal. I understand that no adjustment to the fee will be refunded or cancelled in the event of absence, withdrawal, or dismissal from the School of the above named student(s).

In case of illness, I understand that the School will notify the parent when the student is ill, and the parent will pick up the student as soon as possible.
